Distance - The Annapolis Run is a 10 mile foot race conducted by the Annapolis Striders, Inc. under the sanctioning guidelines of the Road Runners Club of America. Place - Start and finish at Navy-Marine Corps Memorial Stadium, Annapolis, MD. Starting Time - 7:50 AM SHARP! Sunday, August 29,1993. Wheelchair start five minutes prior. All competitors must be at the stadium by 7:15 AM.

Course - TAC Certification #MD90009JS - Splits every mile. Water every 2 miles. Start in east parking lot of stadium; through historic downtown Annapolis into grounds of U.S. Naval Academy; along sea walls through Academy; cross Severn River; shaded country roads; rolling hills; paved surfaces; re-cross River; finish on

Finish Line - Digital Clocks - Three Chutes

Men: use either right or middle chute. Women: use left chute only. Wear your number on the front. After finishing, tear off bottom tag and turn it in at end of
