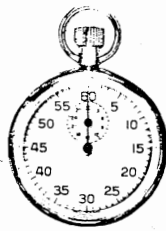


# BOARD MINUTES



HIGHLIGHTS - BOARD MEETING MINUTES

July - December

Discussion about designing a Strider patch has led to the decision to explore a new Strider logo.

Annopolis Ten Mile Race closed at 3,000 entrants. Approximately 1,200 entries were received after 1 July at the \$12.00 rate. The Sports Medicine Center has come through as a much needed last minute sponsor.

The One Mile Track Race will be renamed the John Wall Memorial Track Race as a memorial to John Wall.

There were 2,753 finishers out of slightly over 3 thousand entrants in the Annapolis Ten Mile Run.

The Strider uniform, including a women's style singlet, has been re-ordered.

The club is sponsoring Moore's Marine training this year.

There are currently 710 memberships. We have had 188 new memberships this year.

Don Waddington measured part of the Run Across Maryland route. Some Striders will participate in this run.

Paul Meyer, a Strider as well as a member of the local Hash House Harriers, passed out information about the Harriers and invited Striders to participate.

Fred Pinkum, CPA, and Mat Mace, attorney, are assisting in preparing the club's required IRS report.

Jim Black donated reflective vests for use at races.

Pat Hoffman will be the 1988 Annapolis Ten Mile Run Race Director. Volunteers are being sought for key positions.

The annual 24 Hour Relay held at Fort Meade every summer is soliciting assistance. It needs support if it is to remain viable.
